Subject: Additional Nomination for the Private Sector Advisory Panel

Date: September 14, 2005

[An additional nomination has been received since yesterday for membership on the Private Sector Advisory Panel. The additional name is Dr. Sebahattin Gazanfer. Other nominations are unchanged, and the procedure for approval of nominations is the same. Without objection, the members will be considered confirmed within ten days.]

The membership of the Private Sector Advisory Panel (PSAP) is reviewed by the Standing Committee prior to each plenary meeting to ensure the ongoing relevance and commitment of its members. The terms of service for members of the Sixth PSAP will extend from the 64th Plenary Meeting in Liverpool to the end of the 65th Plenary Meeting in Goiania.

There is no limit to the size of the Panel, except that there may be no more than one member from each country. The Panel must be representative of all three major segments of the world cotton industry, producers, shippers and spinners, and must include members from both developing and developed countries. The Secretariat has received notification of the nominations for the Sixth PSAP shown below. Consistent with customary practices, if there are no objections received within ten days, these members will be considered confirmed.
